



# Before moving forward with the application, check your eligibility and make sure BITRECS is for you!

### A- Mobility check

Situation A: the outgoing phase is run at the beginning of the contract in an institution different from IDIBAPS located in a country different from Spain.

- 1. I have resided 12 months (or less) in the last 3 years prior to the call deadline in the country where I plan to perform my outgoing phase.
- 2. I have resided more than 12 months in the last 3 years prior to the call deadline in the country where I plan to perform my outgoing phase.
- 3. I have never resided in the country where I plan to perform my outgoing phase.

Situation B: If justified, the 36-month contract can be also performed initially at IDIBAPS for up to 6 months followed by the outgoing phase in a country different from Spain. Thus the mobility rule applies to Spain and the outgoing country.

- 1. I have resided 12 months (or less) in the last 3 years prior to the call deadline in either the country where I plan to perform my outgoing phase or Spain.
- 2. I have resided more than 12 months in the last 3 years prior to the call deadline in either the country where I plan to perform my outgoing phase or Spain.
- 3. I have never resided neither in Spain nor in the country where I plan to perform my outgoing phase.

Please note that time spent as part of a procedure for obtaining refugee status under the Genova convention, compulsory national service and/or short stay such as holidays are not taken into account.

## B- Research criteria check

- 1. I have obtained my PhD in the last 5 years prior to the call deadline.
- 2. I have obtained my PhD more than 5 years prior to the call deadline.
- 3. I have not obtained my PhD yet.

#### C- Clinical criteria check

Situation A: The clinical background can be demonstrated because you coursed a clinical residency training

- 1. I completed my clinical residency training in the last 5 years prior to the call deadline.
- 2. I completed my clinical residency training more than 5 years ago prior to the call deadline.
- 3. I have not completed my clinical residency training.





Situation B: The clinical background can be demonstrated because you dedicated part time to the clinical activity and part-time to the research

- 1. I carried out 3 years (or more) of part-time clinical practice whilst performing my research activity.
- 2. I carried out less than 3 years of part-time clinical practice whilst performing my research activity.
- 3. I have never performed any clinical activity whilst performing my research activity.

#### **D- Articles check**

- 1. I am the main author or co-author of one (or more) D1 indexed original article.
- 2. I am the main author or co-author of two (or more) Q1 indexed original articles.
- 3. I am neither main author/co-author of one (or more) D1 indexed original article nor main author/co-author of two (or more) Q1 indexed original articles.

## E- English level check

- 1. I have the B2 level or above (or equivalent) in English.
- 2. I am a native English speaker.
- 3. I use little English in my daily work.

Remember that for the majority of eligibility criteria (research, clinical and English criteria) you should be able to present the corresponding documents (PhD Diploma, Clinical residency training or evidence of performing a part-time clinical activity and level of English).
