

**Before moving forward with the application, check your eligibility and make sure BITRECS is for you!**



## **NEW MOBILITY SCHEME AND ELIGIBILITY CRITERIA**

### **A- MOBILITY CHECK**

#### **Situation A: 36-month incoming scheme at IDIBAPS (Spain)**

1. I have resided 12 months (or less) in the last 3 years prior to the call deadline in Spain.
2. I have resided more than 12 months in the last 3 years prior to the call deadline in Spain.
3. I have never resided in Spain.

#### **Situation B: 12-18 month outgoing phase in a country different from Spain and 18-24 month back at IDIBAPS.**

1. I have resided 12 months (or less) in the last 3 years prior to the call deadline in the country where I plan to perform my outgoing phase.
2. I have resided more than 12 months in the last 3 years prior to the call deadline in the country where I plan to perform my outgoing phase.
3. I have never resided in the country where I plan to perform my outgoing phase.

#### **Situation C (if justified): up to 6 months at IDIBAPS, 12-18 month outgoing phase and 12-18 month back at IDIBAPS. In this case, the mobility rule applies to Spain and the outgoing country.**

1. I have resided 12 months (or less) in the last 3 years prior to the call deadline in either the country where I plan to perform my outgoing phase or Spain.
2. I have resided more than 12 months in the last 3 years prior to the call deadline in either the country where I plan to perform my outgoing phase or Spain.
3. I have never resided neither in Spain nor in the country where I plan to perform my outgoing phase.

*Please note that time spent as part of a procedure for obtaining refugee status under the Geneva convention, compulsory national service and/or short stay such as holidays are not taken into account.*

### **B- CLINICAL CRITERIA CHECK**

#### **Situation A: The clinical background can be demonstrated because you coursed a clinical residency training**

1. I completed my clinical residency training in the last 10 years prior to the call deadline.
2. I completed my clinical residency training more than 10 years ago prior to the call deadline.
3. I have not completed my clinical residency training.

**Situation B: The clinical background can be demonstrated because you dedicated part time to the clinical activity and part-time to research**

1. I carried out 3 years (or more) of part-time clinical practice whilst performing my research activity in the last 10 years prior to the call deadline.
2. I carried out less than 3 years of part-time clinical practice whilst performing my research activity in the last 10 years prior to the call deadline.
3. I have never performed any clinical activity whilst performing my research activity.

**C- RESEARCH CRITERIA CHECK**

1. I obtained my PhD prior to the call deadline.
2. I have not obtained my PhD yet.
3. I am an experienced researcher without PhD but I can demonstrate 4 years full-time equivalent research experience (only available for candidates with clinical residency training).
4. I am a candidate with clinical residency training but I cannot demonstrate 4 years full-time equivalent research experience.

**D- ARTICLES CHECK**

1. I am the main author of one (or more) Q1 indexed original article.
2. I am not main author of one (or more) Q1 indexed original article.



**English is no longer an eligibility criteria but a good command is required to access the programme.**

*Remember that for the research and clinical criteria you should be able to present the corresponding documents (PhD Diploma, Clinical residency training or evidence of clinical or research experience).*
